Sneeze Guards

Deborah Marchand's email regarding the ordering of sneeze guards was sent to all admins (July 1, 2020).

Your first step will be to contact your [ES&H coordinator](#). The coordinator will perform an evaluation of the need. If it's determined the individual could be better protected with a barrier, the ES&H coordinator will recommend the most effective model. Note these are primarily intended for high-traffic areas.

You'll be notified if the barrier is approved and authorized to order through one of these two vendors:

- A. Free-standing sneeze guards may be ordered through JIT supplier [FastSigns](#).
 - B. Fixtures that are attached to the building structure must be requested from [Facilities](#).
- Please save a copy of the approval for your documentation.

As a reminder, sneeze guards do not eliminate the need for face coverings, and should be implemented with a system of layered controls including face coverings, worker rotation, schedule modification, routine disinfection, hand hygiene, etc.
